The below is added to the subject supply order

**Price Variation Formula:-**

ANFO price can be determined using the following two options:

**Option-1:** As per NIT's PV formula ( $Pr = Po (0.10 + 0.846 ANr/ANo + 0.054 HSDr / HSDo)$ ).

1. Definitions of all the component i.e of Pr, Po, ANr etc shall be as per NIT.
2. In this formula the prices of HSD are shown as variable with 5.4% weightage. Since the prices of HSD are variable based on the actual price, which is to be deducted by WCL from M/s Mahadhan Agritech Limited at the prevailing diesel prices, and M/s Mahadhan Agritech Limited is not entitled to claim the HSD component in the above price variation formula. However, if the HSD prices in any subsequent period of the contract is reduced from the "base price as on base date" (Rs 94.27/-), then WCL may invoke and apply the Bid's PVF for the specific month.

**Special Discount:**

In case the value of "ANr" (as per NIT's Price Variation Formula "PVF" definition) exceeds beyond Rs 61,000/- per MT, on a date 5 days prior to the date of ANFO price revision, then M/s Mahadhan Agritech Limited will provide an additional discount of Rs 2000/- per MT on the revised ANFO basic price derived through NIT's Price Variation Formula for subsequent month.

**Option-2:**

**Pr = Prevailing Bulk SME Price in WCL x1.4263 (i.e. 142.63% of prevailing Bulk SME price) less Rs. 2,500/MT discount.**

This is an alternative ANFO pricing mechanism being offered. As per this option, corresponding Basic Prices of ANFO to be computed at 142.63% of prevailing SME prices less discount of Rs. 2500 / MT.

WCL to issue/notify the price applicable for supply of ANFO every month based on the lower of Options-1 & 2 above and WCL shall avail the lower of the above two options for determining ANFO price applicable for each month during the tenure of the contract. For example, ANFO's basic Prices from option 1 & 2 for the month of July'24 is coming as Rs 54,426/- and Rs 54,200/- per MT respectively. So ANFO price applicable for the month of July'24 will be as determined under Option 2, i.e. Rs 54,200/- per MT as being the lower of the two.

**Statutory Obligations:-** a. Item should be supplied only with the approval of valid statutory authority like DGMS, PESO etc whenever it is mandatory. b. The supplier should ensure to get proper written indents / Requisition and no BMD vehicle should be sent without any indent / requisition. This is absolutely imperative.




