Sub : Award of work for Afforestation on Degraded forest land (total 300 Ha.) with 3 (three) years Maintenance, i.e. 100 Ha. in Chandrapur District, 100 Ha. in Yavatmal District and 100 Ha. in Nagpur District, to be undertaken under Corporate Social Responsibility (C.S.R.).

Dear Sir,

With reference to our above Letter of Acceptance, we are pleased to award the subject work in your favour for a value of Rs. 6,06,06,772.50 (Rupees Six Crore Six Lakh Six Thousand Seven Hundred Seventy-two & Paise Fifty only) based on the enclosed Project Cost as submitted by FDCM Ltd. vide letter no. GM/WFP/Turnkey/1773 dated 13.02.2013 for 100 Ha. (Annexure - A) and the enclosed Bi-Partite Agreement format containing the Terms & Conditions as submitted by FDCM Ltd. vide letter no. GM/WFP/Turnkey/28-B/420 dated 12.06.2014 for 100 Ha. (Annexure - B).

The salient conditions of the award are as under :

(1) The Work shall commence within 10 days after handing over of the site by the Forest Department, and the period of completion including maintenance shall be 3 (Three) years from the date of commencement.

(2) The Agreement shall be entered between Forest Development Corporation of Maharashtra Ltd. (FDCM) and Area General Manager of the respective Area of WCL as per the enclosed Project Cost (Annexure-A) and enclosed Bi-Partite Agreement Format containing the terms and conditions (Annexure - B) on a Non-judicial stamp paper of Rs. 100/-.

(3) Payments shall be made to FDCM Ltd. as per the Schedule of Payment contained in the enclosed Agreement format.

(4) All payments shall be made to FDCM Ltd. at Area level by the respective Area of WCL and the paying authority shall be Area General Manager of the respective WCL Area.

(5) The plantation shall be carried out by FDCM Ltd. of multispecies with the proportion of different indigenous species as prescribed in prevalent working plan of the area. Modification & change of species shall be in consultation with the concerned CCF. The species to be planted include inter alia the species of Teak, Shivan, Shishoo, Siras, Bamboo, Kadamb, Khair, Neem, Karanj, Behda, Arjun, Ber, Jamun, Vilati Imli, Aola, Babul, Maharookh, Semal, Amaltas, Bakan, Wad, Pimpal, Bel, Mango, Chinch, Hivar, Umbar, Ritha, Karwandh, Sitafal, Hirda at suitable spacing.

(6) The FDCM shall attach necessary Labour Payment Certificate and Govt. Circular for Minimum Wages as applicable, along with the bills.

(7) Competent and experienced manpower shall be deployed for execution and maintenance of the work.

(8) You shall be responsible for safety and protection of the Plantation work during the currency of the contract and will be required to hand over the same to Forest Department as per the provisions of the Agreement after successful completion of the contract.

(9) The bills of M/s FDCM Ltd. shall be certified for payment by Area level Committee of WCL consisting of Staff Officer (Civil), Area Nodal Officer (Environment) and Area Nodal Officer (CSR).

Further, Nodal Officer (Environment) and Nodal Officer (CSR) of the concerned WCL Area shall co-ordinate this project and shall facilitate in making payments to FDCM Ltd. as per Schedule of payment and shall also ensure that the works are not delayed or interrupted for want of smooth flow of funds.

(10) This Work Order is being sent in duplicate for returning the second copy of the Work Order to the undersigned after affixing your signature as a token of acceptance.

You are requested to contact the Area General Manager of the respective WCL Area, i.e., Chandrapur Area for Chandrapur District, Wani North Area for Yavatmal District and Umrer Area for Nagpur District, for taking up the work under intimation to this office and submit the Action programme along with Non-judicial Stamp Paper of Rs. 100/- for execution of agreement to the respective WCL Area.
