Sub: Award of the work of Collection of Hazardous Waste (WETP Sludge) from opencast Coal mines of WCL in Maharashtra State and disposal at Common Hazardous Waste Treatment, Storage & Disposal Facility (CHWTSDF) at Butibori, Nagpur, authorised by the Maharashtra Pollution Control Board (MPCB).

Dear Sir,

With reference to your offer dated 29.03.2016, and as per the prescribed rates, the Competent Authority is pleased to award the subject work of Collection of Hazardous Waste (WETP Sludge) from opencast coal mines of WCL in Maharashtra State and disposal at Common Hazardous Waste Treatment, Storage & Disposal Facility (CHWTSDF) at Butibori, Nagpur, authorised by the Maharashtra Pollution Control Board, for a value of Rs. 37,03,424.13 (Rupees Thirty Seven Lakhs Three Thousand Four hundred Twenty Four and Thirteen paise only) including service tax with the following stipulations.

- 1) The Agreement in the format earlier followed in work order no. वेकोलि/पर्यावरण/मुख्यालय/17-AF/47 dated 21.04.2015 on a non-judicial stamp paper of Rs.100/- shall be entered between M/s Maharashtra Enviro Power LTD (MEPL), Nagpur and Area General Manager of the respective Area as per the terms and conditions contained therein and quantities to be disposed Area-wise (Annexure-I).
- 2) M/s MEPL shall contact the Area General Manager and Area Nodal Officer (Environment) of the concerned Area of WCL, for execution of agreement and taking up the work with in 7 days of the receipt of this work order, under intimation to this office.
- 3) Before commencement of the execution, the distance between the WETP and CHWTSDF at Butibori shall be physically verified, recorded and signed jointly by M/s MEPL, concerned Area Nodal Officer (Environment) and the Engineer-in-Charge of WETP which shall be maintained as a basic record for payment of transportation charges.

- 4) The date of commencement of Work shall be reckoned from the date of receipt of this work order at your end and the duration of the contract shall be 1 (one) year.
- 5) The Area Nodal Officer (Environment) shall intimate M/s MEPL, the quantum of hazardous waste (WETP sludge) available on month to month basis.
- 6) The payments shall be made to M/s MEPL with respect to the following works/services and as per the following rates verified/accepted by MPCB :

- 7) Loading of hazardous waste (WETP sludge) into the trucks arranged by M/s MEPL, shall be the responsibility of concerned Area/Sub-Area/Unit. The actual quantities loaded by WCL, shall be suitably recorded jointly by M/s MEPL and the Engineer-in-Charge and duly accepted by the Area Nodal Officer (Environment).
- 8) The payment shall be made at Area level by the respective Area of WCL and the paying authority shall be the Area General Manager of the Area.
- 9) At the time of settlement of bills for payment, Challans for Service Tax paid shall be submitted along with the bills for necessary payments.
- 10) You are required to obtain license as per the provisions of Contract Labour (Regulations & Abolition) Act, 1970, and submit the same to the Area General Manager of the respective Area, failing which no bill will be paid against the work done.
- 11) The Work shall be executed and maintained as per the provisions of agreement and instructions of the Engineer-in-Charge.
- 12) The Area Nodal Officer (Environment) shall be responsible for overall coordination and implementation as per schedule and will be assisted by the Nodal Officer (Environment) of the Sub-Area/Unit.
- 13) The Nodal Officer (Environment) of the Sub-Area/Unit shall be the Engineer-in-Charge of the WETP.
- 14) This Work Order is hereby forwarded to M/s MEPL in duplicate. You are requested to return the second copy to the undersigned after affixing your signature with seal in token of acceptance of the Work award.
