Subject	: Letter of Award (LOA)/Work Order for the Consultancy Work of "Assesment, Stability study and analysis of Existing Foot Over Bridges as per latest IS codes along with the suggestion remedial measure of future serviceability of ghugus siding under Wani Area of WCL" on nomination basis as per Memorandum of Understanding (MOU) terms and conditions entered between CIL (Coal India Limited) and M/s IPRCL (M/s Indian Port Rail & Ropeway Corporation Limited) dated 05.03.2020.
Reference	: (i) MOU (Memorandum of Understanding) between M/s IPRCL and CIL dated 05.03.2020. and addendum to MoU dated 19.04.2024 (ii) Your letter vide no MUM/12013/(11)/1/2024 Gen dated 19.07.2024 regarding submission of FSR & DPR.

Dear Sir

With reference to above, this is to communicate the approval of the Competent Authority to award the subject work through this Letter of Award (LOA) / Work Order for taking up the subject work in line with the terms and conditions of MOU (Memorandum of Understanding) entered between CIL and M/s IPRCL dated 05.03.2020 on nomination basis for an estimated cost of **Rs. 11,97,700/- (Rupees Eleven lakh, Ninty Seven thousand, seven hundred only)** including GST @ 18% including IPRCL fees and Railway Security Deposit subject to following:

1. That this Project Management Consultancy is in accordance with MOU signed between CIL and M/s IPRCL to cover all aspects of the subject work beginning from concept to commissioning.
2. That subsequent Addendum dated 19.04.2022 with respect to said MOU dated 05.03.2020 between M/s IPRCL and CIL will also be applicable for the subject work.
3. That subsequent Revised Fee Structure with respect to said MOU dated 05.03.2020 agreed by CIL.

4. That M/s IPRCL will work as a Project Management Consultant of all works entrusted in connection with rail infrastructure and allied civil works including road, all sorts of bridges, box culverts etc. connected thereto for WCL and obtain the relevant Railway Ministry's acceptance of such proposals, which are mandatory for expeditious implementation of projects for the entrusted works. However, the present work is for only consultancy work for assessing whether the present FOB is repairable or new FOB is to be constructed. In the present work, estimated cost is not known and final estimated cost will be derived only after completion of consultancy work and thereafter final approval for Project Management Consultancy beginning from concept to commissioning of the work will be taken up subsequently.
5. Following is the scope of work that will be required to be carried out by IPRCL:
 - (i) Preparation of As Built Drawing of the FOB.
 - (ii) Assessing the structural adequacy of the existing FOB as per latest IS codes and its future serviceability.
 - (iii) Suggestions for appropriate strengthening/retrofitting measures, if existing FOB structure found structurally unstable and future sustainability after strengthening. Strengthening/retrofitting measures should be suggested such that the FOB can be used for both pedestrians and two-wheeler traffic for the next 20-25 years minimum.
 - (iv) Preparation of preliminary design and cost estimate of new FOB.
 - (v) Cost benefit analysis of strengthening works and construction of new FOB
6. That as per approved offer of M/s IPRCL, the abstract of cost with respect to the subject work is as follows: Rs. 10 lakhs (excl. GST) + 1.5% towards IPRCL's FSR and DPR fee + GST i.e. Total Rs.11,97,700.00 including GST.
7. The proposed period of completion for ascertaining structural adequacy and to get estimate will be 60 (Sixty) days from the date of issue of this letter.
8. That pursuant to the above referred MOU, a formal agreement shall be entered into between WCL & M/s IPRCL on work to work basis for setting out the detailed scope of work and methodology of working as per fee, terms & conditions as may be considered mutually acceptable and necessary for successful execution of the works.
9. M/s IPRCL will be responsible for audit observation, CTE observation, Contractor's claim and arbitration, if any.
10. M/s IPRCL will ensure that all taxes and levies (including Goods & Service Tax, surcharge and cess thereon as applicable) and surcharges on taxes, duties and levies, insurance charges, license fees etc. including statutory variations during the currency of the contract applicable on transactions between M/s IPRCL and contractors appointed by M/s IPRCL, if any, shall be payable directly by M/s IPRCL or contractors appointed by M/s IPRCL and WCL will not have any liability whatsoever on this account. However, M/s IPRCL will use the TAN/GSTIN/PAN etc. of WCL wherever necessary to deposit statutory liability and forward the paid challan to WCL for accountal.
11. For the execution of Agreement, following documents are to submitted by M/s IPRCL:
 - (a) Non Judicial Stamp Paper of appropriate value.
 - (b) MOU (Memorandum of Understanding) between M/s IPRCL and CIL dated 05.03.2020.
 - (c) Addendum dated 19.04.2022 with respect to said MOU dated 05.03.2020 between M/s IPRCL and CIL.
 - (d) Revised Fee Structure with respect to said MOU dated 05.03.2020 agreed by CIL.


