विषय/ Sub: Exercising option for 'opt out' from taking supplies in the revised grade by the bidders of CIL e-Auction Scheme 2022 (Single Window Mode Agnostic E-Auction Scheme)

The Notification of Grade/Quality certificate for the year 2024-25 for Pathakhera, Umrer and Nagpur Area in WCL has been published for the information of the customers vide GR.CERT No. PKD/24-25/100/2621, UMR/24-25/100/2617 & NGP/24-25/100/2620 dated 25.07.2024, respectively. In accordance with these certificates, the grade of mines offered in the CIL e-auction events from Tawa UG, Chattarpur-I UG, Amalgamated Inder-Kamptee Deep OCM, Makardhokra-I OCM and Dinesh (Makardhokra-III) OCM has been changed w.e.f. 00;00 Hrs of 26.07.2024. The supplies in the revised/changed grade will be made from Tawa UG and Chattarpur-I UG. However, for the remaining three (3) mines supplies will be made to the e-Auction bidders from the stock of the pre-revised (bid) grade.

The customers are already aware that as per Clause No. 5.5 of the terms of Single Window Mode Agnostic E-Auction Scheme, they can opt out from taking coal in the revised/changed grade by submitting application within 5 days of such notification. The above said grade certificate for change in grade from Tawa UG and Chattarpur-I UG was notified on 25.07.2024 and as such, the application for opt out from taking supplies in the revised/ changed grade from the Tawa UG and Chattarpur-I UG has to be submitted on or before 30.07.2024 at the Pathakhera Area Office of WCL for the running sales orders and at Road Sales Section, M&S Dept., WCL for the sales order yet to be released.

It is further clarified that as per the communication received from the areas, for the remaing three mines viz. Amalgamated Inder-Kamptee Deep OCM, Makardhokra-I OCM and Dinesh (Makardhokra-III) OCM Areas will continue to deliver coal against the running sale orders and also for sales orders yet to be issued under CIL eauction held on 20.07.2024 & 26.07.2024 at the pre revised grade (i.e. at the bid grade of coal) from the stock of the previously notified grade (i.e. the bid grade) and the customers are bound to accept such coal. In case of the failure of the customers to lift the coal offered for lifting at previously notified grade (i.e. the bid grade), the bid security will be forfeited as per the provisions of the scheme.
