- No coal is to delivered until Sub Area Manager copy as well as consumers copy duly signed by Area Sales Manager is received at colliery end
- The trucks should be allowed strictly as per weekly allotment given by Area Sales Department, as the same is being uploaded on WCL website weekly.
- Ones weekly allotment is issued; unit is not authorised to add or make any changes in weekly program.
- Customer who are reluctant to load trucks after deployment, their trucks be canceled immediately for making way for the next truck in the sequence for weighment and loading.
- This program is allocated considering the pending number of trucks awaited to be loaded at Check Post
