The respective %bid premium (% premium over the notified price) of the bidder under the FSA for supply from Sasti OCM shall be applicable for supply of coal from the Pouni II OCM under  $G-11\ Cr$ . ROM grade of Coal.

The modalities to be followed in case of transfer to the secondary sources are as follows:

## A. For Sales Orders having nil lifted qty.:

- Supplementary Proforma Invoice shall be issued for enabling consumers to pay differential STC amount for Pouni II OCM, since the STC charges for Sasti OCM and Pouni II OCM fall under different slabs.
- The consumers who are willing to lift the coal from secondary source are advised to make the payment against the supplementary PI within 7 days i.e. 09.08.2024 or validity of the sale order, whichever is earlier so that their Sale Orders with secondary source can be issued for lifting.

### B. For Partially lifted Sale Orders:

- The existing Sale Orders of primary source shall be closed and balance amount will be refunded as per the refund procedure to the concerned customers.
- For allocating fresh Sale Orders with secondary source, Proforma Invoice for new Sale Order of secondary source will be issued. The payment against the Proforma Invoice should be made within 7 days i.e 09.08.2024 or validity of the sale order, whichever is earlier.

Further, the concerned customers are advised to submit payment intimation for issuance of Sale Order to the office of the undersigned. The Sale Order validity shall remain unchanged.
