Sub: Revision of Surface Transportation Charges from pit-head to loading point of coal for all existing lead distance w.e.f. 00:00 hrs of 25.06.2024

This is for the information of all customers/ bidders of WCL that the Surface Transportation Charges (STC) from pit head to loading point of coal for all existing lead distances effective from 00:00 hrs of 25.06.2024 will be as under:-

Distance Slab (Kms)	Revised STC Rate (Rs./Tonne)
0 to 3	48
3 to 10	82
10 to 20	134
Above 20	Actual + 10%

For the balance quantities to be delivered against the Sale Orders as on 00:00 hrs of 25.06.2024, all Areas are advised to issue Supplementary Pro-forma invoice to customers / bidders for STC applicable for the un-lifted quantity of valid Sale Orders for collection of differential payment through bank interface after ensuring the completion of Delivery Creation in ERP upto 24.06.2024. The supplementary Proforma Invoices be issued latest by 29th June'2024 without fail or within validity of SO, whichever is earlier. The last date for making payment against Supplementary Proforma Invoice shall be 06.07.2024 or validity of Sale Orders whichever is earlier.

The Areas shall ensure withholding the delivery of balance quantities against respective Sale Orders in proportion to the amount recoverable due to revision of STC till such time the differential amount is not remitted by the customers / bidders against the Supplementary Proforma Invoice.

For the DOs pending to be issued at HQ as on 25.06.2024, fresh Pro-forma invoice shall be issued by concerned section to the customers / bidders.
