Dear Sir,

This is with reference to the awarded GeM Contract/ work order as per NIT for the work of Hiring of 02 Nos. Tata sumo or equivalent vehicle for 12 Hrs per day with provision of One driver with intermittent rest, Avg. run of 100 km/day against Survey off vehicle no. MH34-C8160 for mining Pool, DOCM & MH34-F1191 for Excavation Dept., DOCM, DSA, Chandrapur Area against the above GeM-tender and your GeM-offer.

You have withdrawn both hired vehicle nos. MH29-BE6659 (Mining Dept) and MH29-BE6657 (Excv Dept) without information to concerned authority since 08.06.2024. Hence, the SAM, DSA had issued letter to the contractor vide ref. no. 997 dated 11/13.06.2024 (Copy of letter issued by SAM, DSA, enclosed herewith). Accordingly, following letters and Notice have been issued through Email and by post to the contractor.

In-spite of notice and verbal communication, services of the vehicles was not provided, due to which production and safety affects the day to day activities of mines.

Your firm had not responded for the above related issues against the Notice no. वेकोलि/चंद्रपुर/क्षे.म.प्र/वि एवं यां/2310 दिनांक 29.06.2024 and also your firm did not show any interest to rectify the problem.

As per GeM Contract/ NIT, the clauses for the failure on your part are as follows:

### 1. Penalty: (GeM Contract Clause 9)

- 1.1 In case the contractor fails to provide a vehicle for a particular period(s)/runs the vehicle without valid RTO permit, RTO Registration, Comprehensive Insurance of vehicle, valid driver license and Fitness Certificate, he will not get the hiring charges for that period and additional penalty of Hiring charges on hourly basis (pro rata on daily hiring charges) will be deducted from his bill for the period of absence from duties.
- 1.2 In the event of the contractor failing to provide the vehicle(s) on time and the company going in for hiring of another vehicle(s) from outside agency to adhere to the time schedule of the Company's work, the difference in amount to be paid to the outside agency and that of the contractor under the hiring contract, will be deducted from the bill(s) submitted by the contractor. But if such expenses incurred by the department are less, the difference shall not be paid to the contractor. This will be in addition to penalty deducted under clause (a) above.
- 1.3 If the Company suffers any loss on account of damage to its property, due to any failure on the part of contractor or due to any act or omission or commission on the part of his representative/employees or from the vehicle of the contractor, the value of the same as assessed by the company, shall be recovered from the contractor's bill/security deposit. The decision of the company in this regard shall be final and binding to the contractor.
- 2. **Termination of Contract as per NIT (GeM contract clause: 16):** (a) In case the performance of the party during any time of the contract period is found unsatisfactory, the company may terminate the contract by giving one month's advance notice.
- 3. Banning Business (General Terms and condition of NIT Clause: 17 (2(iv)) The contracting entity may be banned in the circumstances: In case of failure to execute the work as per mutually agreed work schedule as per NIT. Clause 17(4) The banning shall be for a minimum period of one year and shall be effective for WCL for the tenders invited at Area/Subsidiary level.

### 4. Bidder instruction of NIT Clause:

14.5 The Bid Security/Earnest Money may be forfeited:

- a. if the Bidder withdraws the Bid after Bid opening during the period of Bid validity / extended validity with mutual consent; or
- b. in the case of a successful Bidder, if the Bidder fails within the specified time limit to:
- (i) sign the Agreement; or
- (ii) furnish the required Performance Security/ Security Deposit.

Additionally the company reserves the right to debar such defaulting contractor from participating in future bids for a minimum period of 12(twelve) months.

- 14.6 The Bid Security/ EMD deposited with the Employer will not carry any interest
- 5. The Agreement will incorporate all agreements between the Employer and the successful Bidder within 28 days following notification of award along with the letter of Acceptance and / or Work Order issued by department. In case of failure to enter in to agreement within specified period or extended period on the request of the bidder, if any, the department in addition to other penal measures as per clause 14.5 of Instruction to bidder (ITB) shall be at liberty to debar the selected bidder from participating in future Bids for at least 12 months.

All the above terms and conditions as per GeM contract / NIT are violated on your part.

MH34-C8160 for Mining Pool, DOCM & MH34-F1191 for Excavation Dept., DOCM, DSA, Chandrapur Area".
- 2. Performance Security (i.e., 3% of work awarded value) Rs.1,00,700/- had been deposited by your firm M/s Jagannath Tours & Travels, Wani, Yavatmal in the form of bid security against LOA is hereby forfeited as per NIT.
