विषय/ Sub: Modalities for deposition of differential payment for supply of coal in revised grade

In connection to the notice no. WCL/M&S/2024/128 dt 27.07.2024 of GM (M&S), WCL, the bidders who have booked coal from Tawa UG & Chattarpur-I UG under CIL e-auction Scheme 2022 held on 31.05.2024 and 19.07.2024 are hereby informed that the modalities for depositing the differential amount for supply of coal in A 18 8 10 15 the revised grade are as follows:-

1. For Sales Orders running at Area: - The bidders/customers are required to deposit the differential amount in the SBI, Coal Estate Branch account of WCL. The details of the account are mentioned below:-

Account No: - 10205966080 IFSC Code: - SBIN0009060 Branch: - Coal Estate, Nagpur.

After making the payment of the differential amount, the respective bidders are requested to give intimation of the transaction to the respective Area Sales Manager (ASM) first. The ASM is then required to send the details viz. customer code (billed to), customer name, Sales Order No., Sales Order date (Valid from & Valid to), Balance SO quantity, Payment Ref. No. & Date, Amount deposited etc., in the excel format for confirmation of payment to WCL-HQ. After the confirmation is received from the WCL-HQ then only the withhold quantity is to be released by the area.

The last date of depositing the differential payment shall be the validity date of the sales order or 10.08.2024, whichever is earlier.

2. For Sales Order yet to be released from HQ: - Revised PI has been issued and mailed to the respective email id of the bidders through ERP/SAP. The bidders of e-auction held on 19.07.2024, are hereby informed that last date of making the main coal value payment will remain the same i.e. 31.07.2024 & the differential coal value payment against the revised PI is to be deposited on and before 10.08.2024 through CIL ICICI e-collection paintal.

In both the aforesaid cases, if the customer fails to either deposit the differential amount by the last date i.e. 10.08.2024 or the option of OPT OUT by 30.07.2024 then the Bid Security (EMD) towards the withhold/ booked quantity will be forfeited as per the terms and conditions of the CIL e-auction Scheme 2022.
