Sub: Notice for NRS Linkage Auction consumers procuring coal from Makardhokra -I OCM.

Consequent upon Annual Grade Declaration for the Financial year 2024-25, effective from 00.00 hrs of 01.04.2024, grades of three sources (ie Dinesh (Makardhokra-III) OCM, Makardhokra-I OCM & Amalgamated Inder Kamptee Deep OCM) had been revised. Vide this office Notice No. NGP/WCL/M&S/11 dated 03.04.2024, NRS Linkage Auction consumers having FSA for supplies from these sources had been served notice as per clause 2.3 of Fuel Supply Agreement.

Further vide this office Notice No. NGP/WCL/M&S/33 dated 06.04.2024, it had been clarified that in case the area is offering delivery of coal from above cited three sources to NRS linkage Auction consumers in the pre revised grade (ie applicable prior to 00.00 hrs of 01.04.2024) from the stock of the previously notified grade, the consumers are bound to accept such coal.

In reference to information received from Umrer Area, all NRS linkage Auction FSA consumers procuring coal by Road mode from Makardhokra-I OCM are informed as under:

- 1. All pending sales orders will be issued with revised grade (applicable from 00.00 hrs of 01.04.2024) for revised Annual Contracted Quantity (ACQ) as informed vide above cited notice dated 03.04.2024.
- 2. The PI in respect of sales order, pending to be issued are raised/shall be issued for the revised grade for payment. The NRS Linkage Auction consumers willing to accept supply of coal in the revised grade, can remit payment against the PIs issued for the revised grade by 20th May 2024.

The consumers would also be required to enhance the amount of performance security (as per details given in the enclosed list) within 7 days of issuance of this notice.
