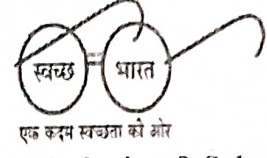

Sub: Notice for NRS Linkage Auction consumers procuring coal from Gokul OCM.

Consequent upon Grade Notification No. UMR/24-25/100/2617 dated 25.07.2024 effective from 00.00 hrs of 26.07.2024, grade of Gokul OCM had been revised from G11 CROM to G7 CROM. Vide this office Notice No. NGP/WCL/M&S/556 dated 09.08.2024, NRS Linkage Auction consumers having Fuel Supply Agreement (FSA) for supply of coal from above cited source had been informed revised ACQ applicable after revision of grade.

Now, vide Grade Notification No. UMR/24-25/100/2701 dated 03/04.09.2024 effective from 00.00 hrs of 03.09.2024 the grade of Gokul OCM had been revised from G7 CROM to G11 CROM. On notification of the same, all NRS Linkage Auction consumers of Gokul OCM are informed that:

- The Annual Contracted Quantity (ACQ) of valid FSA executed with NRS Linkage Auction (Tranche IV to VII) consumers procuring coal by road mode is further restored for quantity for which FSA had been executed.
- On notification of G7 CROM grade of Gokul OCM vide above mentioned notice No. 09.08.2024, few consumers have applied for exit from FSA. Now, on restoration of grade of Gokul OCM to G11 CROM (ie bid Grade) these consumers can avail supply of G11 CROM coal from Gokul OCM by submitting consent by 30.09.2024.
- All Performa Invoice for which payment had been made by consumers but delivery order is yet to be issued will be issued with revised grade ie G11 CROM.
