The IPP consumers having valid FSAs with WCL and willing to opt for allocation of coal beyond ACQ, against their MSQ entitlement for the period of Oct 24 to Dec 24 are being offered coal by Road Mode from following sources.:-

The offer of coal beyond Annual Contracted Quantity without any upper ceiling is being made in reference to CIL letter No. CIL/M&S/Flexi/300 dated 08.07.2024, letter No. CIL/M&S/Flexi/436 dated 18.09.2024 and other such orders issued in this regard.

Following modalities will be applicable for supplies beyond Annual Contracted Quantity for FY 2024-25 :-

1. The purchaser is required to submit an application clearly mentioning the desired additional quantity beyond ACQ and the order of preference of offered source on or before 25.11.2024. Based on application received, allocation shall be made after 25.11.2024, ie. After last date for submission of application.
2. In case of total applied quantity by all willing IPPs is more than offered quantity, the allocation shall be prorated based on applied quantity by each IPP.
3. Coal supply beyond ACQ shall be allowed to IPPs provided it is enabled in their signed FSAs. Other Documents shall be taken as per terms & condition of relevant FSAs.
4. PI shall be applicable as per the provisions of the FSAs against supplies beyond ACQ.
5. a) In case the eligible IPP is willing to lift coal in a single installment, the last date of payment for the same will be 02.12.2024. b) For IPPs opting to lift coal in 3 equal installments, the last date of payment shall be 02.12.2024 for the first installment, 11.12.2024 for the second installment and 31.12.2024 for the third installment


In context of the captioned subject, it is to convey that CIL Board in its 467th meeting held on 27.06.2024 has approved the following:

- a. *Coal Supply beyond ACQ shall be allowed to IPPs provided it is enabled in the signed FSAs. Other documents shall continue to be taken as per the terms & conditions of relevant FSAs.*
- b. *Above decision shall be applicable for FY 24-25 and onwards. For FY 23-24, the IPPs shall be required to submit the CEA certificate as per earlier approved modalities.*

Sub: Clarification regarding allocation of coal beyond ACQ to eligible power houses

Dear Sir(s),

This refers to CIL letter no. CIL/M&S/Flexi/300 dated 08.07.24 vide which the decision of 467th CIL board regarding the modalities of coal supply beyond ACQ was conveyed.

Subsequently, some coal companies have sought certain clarifications.

Considering the same, the following is hereby clarified:

- For FY 2023-24, for supply beyond ACQ upto 120%, submission of CEA certificate by IPPs, is to be complied with. Such certificate has to be deposited by 30th June 2024.
- For the subsequent years, i.e. from 2024-25 onwards, supply beyond ACQ may be without any upper ceiling, subject to the presence of such enabling provisions/ clauses in the respective FSAs and availability of coal at the despatch locations of the coal company.
- Variation in QQ & SQ and PI applicability shall be as per provisions of FSAs read with decision of 467th CIL Board, circulated vide aforesaid letter dated 08.07.2024 of CIL.
