The verification process shall be carried out by the committee constituted for the purpose at Office of the Area Security Officer, located at Area General Manager's Office, Majri Area, Kuchana Complex, Ta- Bhadrawati, DI- Chandrapur- 442503 on the prescribed date and time mentioned in the attached list

All enlisted aspirants are advised to attend the document verification process positively on the date and time (10.30 a.m. to 2 p.m) allotted to them as mentioned in the list, before the committee Date and time of verification is final. However in case of extreme emergency situation if a candidate fail to attend the document verification process on scheduled time and date, if he produces a valid reason before the committee, he will be given another opportunity.

**Note for Candidates:**

- a. This engagement as apprentices does not guarantee any employment to the candidates with the establishment i.e .WCL, Majri Area. Apprentice Training shall be terminated immediately after completion of one year from the date of joining as Apprentice.
- b. Apprentices after selection and joining shall be entitled only to get Monthly stipend as prescribed in the Gazette Notification. There is no provision to reimburse any Travelling Allowance of other type of expenditure during Verification process, Medical examination or joining at any unit or attending any theoretical training during apprenticeship.
