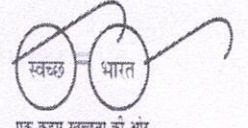

1.	ED (Land & Rehabilitation)	The incumbent would be responsible for framing and adhering to policy on Land & Rehabilitation & Resettlement. He shall monitor and resolve all legal issues relating to land. He shall involve in planning, Monitoring, Acquisition/physical possession of Land and R&R including mining lease. He shall monitor all land related issues of CIL & its subsidiaries to ensure the required land is always available for mining and related activities The incumbent would report to Director (Technical), CIL	Graduate in any discipline	2 years' service in E8 grade.  And  Out of last 10 years' Experience, 5 Years' work experience in Land/R&R department.
2.	ED (Solar)	The incumbent would be responsible for planning, Monitoring & implementation of all solar projects across CIL and its all subsidiaries and to monitor the vertical of all solar activities. The incumbent would report to Director (Technical), CIL	Degree in Electrical/Mechanical/Civil/Mining Engineering	2 years' service in E8 grade.

Note: As decided by CIL Board, the criteria for both the posts shall be reviewed by the Board after 5 years.
