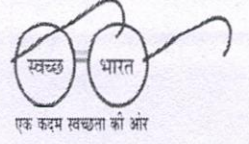


आदेश
