ORDER

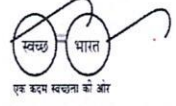


