
On being released, from his present place of posting, he is advised to report to the Area General Manager, Umrer Area for his further assignments.

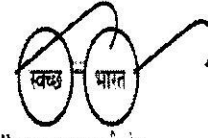


