Sub : Award of Work for taking up 50 ha plantation on forest land under CSR for 2015.

Dear Sir,

With reference to your above referred offer we are pleased to award the subject work in your favour for a value of Rs. 1,20,35,346.08 (Rupees One Crore, Twenty Lakhs, Thirty Five Thousand, Three Hundred Forty Six and Eight paise only) based on the enclosed project cost as submitted by FDCM Ltd (Annexure-A) with following stipulations :-

- (1) The Agreement on a non-judicial stamp paper of Rs. 100/- shall be entered between (Area General Manager) AGM Chandrapur Area, Western Coalfields Ltd, and Divisional Manager, FDCM, Chandrapur as per the enclosed project cost (Annexure-A). A copy of agreement executed against previous work order for plantation over 300 ha of degraded forest land (Annexure-B) is enclosed herewith, which has to be suitably modified in confirmation with this Work Order.
- (2) The work shall commenced within 10 days from the date of issue of this Work Order and the period of completion including maintenance shall be 3 (Three) years from the date of commencement.
- (3) Payment shall be made to FDCM Ltd. As per the Schedule of Payment contained in the enclosed Agreement format.
- (4) All payments shall be made to FDCM Ltd. At Area level and the paying authority shall be Area General Manager, Chandrapur Area.
- (5) The plantation shall be carried out by FDCM Ltd and the species to be planted shall be same as was done on 100 ha of degraded forest land as per clause no. (5) of our earlier work order no. WCL/ENV/HQ/17-AR & 23-D/ 104, dated 25.03.2014.
- (6) The FDCM Ltd shall attach necessary Labour Payment Certificate and Govt. Circular for Minimum Wages as applicable, along with the bills.

- (7) Competent and experienced manpower shall be deployed for execution and maintenance of the work.
- (8) You shall be responsible for safety and protection of the Plantation work during the currency of the contract and will be required to hand over the same to Forest Department as per the provisions of the Agreement after successful completion of the contract.
- (9) The bills of FDCM Ltd shall be certified for payment by Area level Committee of WCL consisting of Staff Officer (Civil), Area Nodal Officer (Environment) and Area Nodal Officer (CSR).


Further Nodal Officer (Environment) and Nodal Officer (CSR) of Chandrapur Area shall co-ordinate this project and shall facilitate in making payments to FDCM Ltd. as per Schedule of payment and shall also ensure that the work is not delayed or interrupted for want of smooth flow of funds.

- (10) This Work Order is being sent in duplicate for returning the second copy of the work order to the undersigned after affixing your signature as a token of acceptance.

You are requested to contact the Area General Manager Chandrapur Area of WCL for taking up the work under intimation to this office and submit the action programme along with Non-Judicial Stamp Paper of Rs. 100/- for execution of agreement.
