- Assessment of plantations at biologically reclaimed areas (like external and internal dumps and backfilled areas), greenbelts and other afforestation sites for survival and growth attributes.
- iii. Biodiversity (terrestrial floral and faunal groups) enrichment study in reclaimed areas, green belts, avenue plantation and other afforestation sites.
- iv. Biodiversity study in natural vegetation in unbroken area, if any, in the mine lease.
- v. Aquatic diversity study in natural drainage and sumps (water bodies), if any, in the mine lease and it's surrounding.
- vi. Study on soil nutrient and soil microorganisms from the biologically reclaimed sites.
- vii. Study on efficacy of mitigation measures implemented for reclamation of mined area.
- viii. Study on the impact of reclamation on the management of soil erosion and water quality from the mine lease.
  - ix. Recommendation for further improvement in the ecology of the mining area.
