Thousand Eighty-Two Only including GST @ 18%) with inclusion of additional parameters as per ECs issued by MoEF&CC (i.e.1. monitoring of mercury (Hg) in heavy metals monitoring in air & 2. Monitoring of ozone (O3) in Air) with following details:

- Time Period: 1-year i.e. 1st April'2022 to 31st March 2023.
- Monitoring should be done as per IS standards / CPCB guidelines.
- Deliverables: Monthly Routine Environmental Monitoring reports in respect of all projects / mines of WCL both in soft and Hard copy
 - Hard copy to respective areas – Monthly one copy each.
 - Soft copy of reports (both word and excel sheets) to respective areas & WCL-HQ.
- Bills have to be submitted along with a copy of certification from Area Nodal Officer (ENV) for sampling works and will be passed only after receipt of monitoring reports.
- The processing authority of bill is office of GM(Environment) / HOD, WCL-HQ.
- The final payment will be released by the office of GM(Finance), WCL-HQ, Nagpur in deference to the Budget Certification no. BC/WCL/REV/GM(ENV)/2022-23/MONITORING & AUDIT/01/01/166 dated, 02.06.2022 issued for Rs.26,09,60,082/- (Rupees Twenty-Six Crore Nine Lakhs Sixty Thousand Eighty-Two Only) including GST @ 18%.
