This has reference to above mentioned communications between WCL & CMPDIL mentioned in ref (3) & (4) on the subject work and our letter no. WCL/HQ/ENV/14-I/294-307 dated 01.04.2023 conveying the approval of Empowered Committee of Functional Directors (ECOFD's) headed by CMD, WCL for award of work to CMPDIL, RI-IV, Nagpur on nomination basis for Routine Environmental Monitoring Work for the year, 2023-24 with an estimated amount of ₹ 35,84,03,994.00 (Rupees Thirty-Five Crore Eighty-Four Lakhs Three Thousand Nine Hundred and Ninety-Four Only) including GST (@ 18%).

Further to this, based on the approval of ECOFD's, this is to award the subject work to M/S CMPDIL, RI-IV, Nagpur for a total value of ₹ 30,37,32,198.00 (Rupees Thirty Crore Thirty-Seven Lakhs Thirty-Two Thousand One Hundred and Ninety-Eight Only) excluding GST and ₹ 35,84,03,994.00 (Rupees Thirty-Five Crore Eighty-Four Lakhs Three Thousand Nine Hundred and Ninety-Four Only) including GST (@ 18%) with following details:

- Time Period: 1-year i.e 1st April'2023 to 31st March 2024.

    - c. Monthly monitoring data in the excel sheets as per the enclosed formats.
  - Monthly exceptional reports along with mitigation measures.
- Bills have to be submitted along with a copy of certification from Area Nodal Officer (ENV) for sampling works and will be passed only after receipt of monitoring reports.
- The processing authority of bill is office of GM(Environment) / HOD, WCL-HQ.
- The final payment will be released by the office of GM(Finance), WCL-HQ, Nagpur in deference to the Budget Certification no. BC/WCL/REV/GM(ENV)/2023-24/BY CMPDI AIR, WATER, NOISE & OTHERS/01/01/127 dated, 13.06.2023 issued for Rs.35,84,03,994/- (Rupees Thirty-Five Crore Eighty-Four Lakhs Three Thousand Nine Hundred and Ninety-Four Only) including GST @ 18%.
